FLAT TUMMY PATCH



PRODUCT DESCRIPTION

This is a product with anti-cellulite and reducing action specifically for the stomach.

The main objective achieved is to reduce the stomach area, leaving it flatter and firmer. This objective is achieved through active plant ingredients (green tea to eliminate retained liquids and alga laminaria to act on lipid metabolism) that exert their action on both the epidermis as well as on the deeper layers of the skin.

The release of the active ingredients is sustained and gradual over time, so that constant availability of its beneficial effects is ensured for 24 hours.

This is a product formulated with **patch technology**. It consists of a waterproof film with an adhesive layer containing the dispersed active ingredients. When this adhesive gets in contact with the skin, it gradually releases the active ingredients, thereby achieving sustained action.

— INDICATIONS -

The Flat Tummy patch is designed for those who want to achieve a more slender figure by reducing stomach and waist volume.

Patch technology, unlike what happens with creams and other conventional treatments, achieves sustained effect for 24 hours.

Especially suitable when a routine for weight loss is being followed as the effects will be enhanced thanks to the action of the product's active ingredients that help activate fat metabolism, losing volume more noticeably than with diet alone.

THE ACTIVE INGREDIENTS -

The Flat Tummy patch has natural active ingredients of proven efficacy in reducing volume:

LAMINARIA DIGITATA: The laminaria alga is used as a mobiliser alga and fat burner. Besides being a popular ingredient in Asian cuisine (along with other Laminaria species, once dried it is known as kombu). With a high iodine content, in part responsible for its action. As well as re-mineralising skin treated with it.

CAMELLIA SINENSIS: Green tea contains a high level of caffeine (known as theine). Caffeine's properties as a lipo-reducer are widely known and it has been used for many years as an ingredient in anti-cellulite creams. It has a marked draining effect, which helps mobilise the liquids retained in the abdominal area.

— INSTRUCTIONS FOR USE -

Ensure that the area where the patch will be applied is clean and dry, to ensure perfect adhesion. Once the patch has been applied, it will remain in place even when showering, sweating or doing any other activities.

- 1) Cut the foil sachet and remove one of the films it contains. Separate one of the patches from the support film and stick it on the chosen area of skin.
- 2) The patch must stay applied to the skin for 24 hours.
- 3) On the next day, remove the patch and reapply, varying the point of application. The treatment can be repeated throughout the year, resting 2 weeks between each two-month treatment. The patch is easily removed. Detach one end and then pull gently. There is no need to rinse or wash the area afterwards.
